Core Course - Governance Fundamentals: Developing Stronger Child, Youth and Family Service Boards.

From recruitment and orientation to continuous development and peer learning, **tng**'s Child, Youth & Family Services Director Certification Program is a sector-specific, online training course designed to strengthen board performance at every stage. Built on decades of experience working with not-for-profit boards, this practical and accessible program supports Directors with clear guidance, real-world tools, and ongoing governance support, laying the foundation for effective, accountable, and confident board leadership.

Your agency's subscription to the Directors Certification Program includes up to 15 seats per year (Directors and senior staff) and provides seamless access to a full-service, no-fuss program:

Online, Self-Directed Course Content

Directors and participants can complete the program on their own schedule, from any device. Each agency will have the ability to set the length of time participants will have to complete the program.



Ongoing Access for Directors

Once enrolled, each participant retains access to the course and supplemental materials for the duration of their service as a Director with your agency, ensuring a consistent reference and learning resource over time.

Qualifying New Director Candidates

By request, this program was designed to allow Director candidates access to the first two modules, providing early insight into Board responsibilities and fostering alignment between expectations and motivations. This approach supports more effective recruitment and succession planning, contributing to long-term governance strength and continuity.

What's Included in the Program

1. Governance Fundamentals (Core Certification Course)

An engaging, sector-specific course that covers foundational governance concepts, duties, and best practices. Directors and staff earn a certificate of completion upon completing the program.



2. Private Forum + Ask the Expert

Your Directors can post questions in a private forum (accessible only to your agency and **tng**), and receive thoughtful, expert responses from **tng**'s governance advisors within one business day. In addition, Directors can use the forum for peer learning and to discuss the application of concepts within the course amongst each other (respecting agency/Director confidentiality of course!).

3. Annual Executive Director + Board Chair Leadership Roundtable

An annual facilitated session that brings together Executive Directors and Board Chairs from participating agencies for shared learning, peer exchange, and practical discussion on sector-specific governance challenges. Pre-scheduled and facilitated by **tng**, the forum is designed to strengthen the partnership between governance and leadership in a confidential, supportive setting.


4. Annual Governance Refresher Course(s)

Designed for returning Directors who have previously completed the Governance Fundamentals, this online course includes customized case studies and knowledge checks that reinforce key principles and offer practical learning through real-world scenarios.

5. Annual 'Pulse Check' Board Assessment

A brief, anonymous online assessment that helps your Board assess its performance, identify emerging issues, and identify opportunities for improvement. Results are compiled in a confidential summary report with key insights to support ongoing development and governance effectiveness.

Governance Fundamentals Course Structure

The Governance Fundamentals course is organized into 8 core modules; each focused on building practical governance competence. The first two modules* have been designed to support Director recruiting.

| 2* Director Roles & Responsibilities | Introduction to the fiduciary relationship, code of conduct, terms of office and term limits, time commitment, application process, interviews, selection and orientation. |
| 3 Board Structure & Legal Responsibilities | Overview of legislation, Ministry and OACAS ecosystem, agency bylaws, Board Governance policies, organizational overview, Director liability and D&O coverage. |
| 4 Effective Meetings | What to expect at a meeting, ingredients of a good meeting, effective decision-making, the role of the Board Chair, the role of the Executive Director, meeting preparation, meeting participation, meeting minutes, in camera sessions, meeting evaluations, post-meeting reflections. |
| 5 Effective Delegation | Delegation to Board committees, committee terms of reference and workplans, effective committee meetings, forming recommendations, the Board's role in committee accountability, the Board-ED relationship, executive limitations, ED roles and responsibilities, reporting structure, the Board's role in ED accountability, effective performance management. |
| 6 Stewardship & Oversight | The Board's role in: monitoring performance, financial stewardship, risk stewardship, program quality stewardship, community engagement, media/advocacy, and the audit process. |
| 7 Aligning Strategy, Performance, & Operations | Role of the strategic plan, planning framework and cycle, the planning process, approval, review and fine-tuning, performance outcomes (ministry required, KPI's, Scorecards and Dashboards) Tying it all together: strategic plan, operational plan, budget. |
| 8 Optimizing Board Performance | Avoiding common governance issues, best practice standards and evaluations, board and governance work plans, Director training and development, Director succession planning, and recruitment. |
| 9 Optional: Governance Leadership (for Vice Chairs & Chairs) | Understanding the role of the Chair, leading effective Board meetings, the Chair-ED relationship, managing Board dynamics, developing your leadership skills. |

Modules are interactive and accessible. Interactive knowledge-checks are woven throughout, and each module concludes with a short quiz to assess progress. Following the completion of Module 8, participants will complete an exam that tests their understanding of fundamental governance concepts.

All content has been customized for child, youth, and family service boards, incorporating language, examples, and challenges drawn directly from sector practice and Ministry expectations.

FAQ's

How long does the course take to complete?

The Governance Fundamentals course takes approximately 6-10 hours to complete. Because it's self-directed, it can be completed in shorter sessions over time, or in longer sessions. It's up to each individual to determine what works best for them.

Can we set deadlines for our Directors to complete the course?

Yes. Each organization can set a course expiry date based on each person's enrollment date. We generally recommend allowing for 4-6 weeks for completion, though we recognize that this timing depends on each agency's unique requirements.

Has this course been validated by the Child, Youth and Family services sector?

This program was commissioned by a group of agencies in the sector, and they were involved in the development of the program from start to finish.

Does our organization need to manage user accounts or provide tech support?

No. Your annual fee includes course administration from **tng** and ongoing tech support from our learning management software provider, SkillBuilder.

How will we know when a Director finishes the core course?

Your Director will receive notification as well as their certificate; we will provide regular reporting while Directors are actively taking the course.

Is the Forum moderated?

Yes, our team will be moderating the forum and responding to posts in the "Ask the Expert" section.

Is there flexibility if we need more than 15 seats?

Yes. Additional seats are available for \$450 + applicable taxes each per year and can be added at any time.

What if we want additional customization?

Currently, each organization's course has the option for basic customization, such as the inclusion of your current bylaws. We are happy to offer further customization for a fee. Please contact us to discuss your needs.

Does this replace in-person Director Orientation?

Not necessarily. While it can be used as a stand-alone solution, our experience shows that in-person sessions are often very valuable. Delivering the foundational content online allows in-person sessions to focus more effectively on specific topics, making them more dynamic and engaging. Too often, we find that Director Orientation sessions are spent on the basics; this course is meant to cover those basics, plus topics that often get minimal attention.

What if some of the content needs updating? For example, if there are changes to legislation or other best practices?

We have scheduled annual updates to the course to ensure it remains current. Participating organizations will receive advance notice of the annual update and be invited to submit feedback and change-requests. We also welcome feedback and input from our program users at any time.
